1. I/We have read and understood all of the material and information contained in the information pack, which came with this form.
2. I/We acknowledge that our participation in this project is voluntary, neither party is obliged to proceed and may withdraw from the process at any time prior to settlement.
3. The sale will not become final and binding until all of the following have occurred:
 - 3-A. You have advised me/us that the project partners have decided to go ahead with the purchase.
 - 3-B. You have received the original Certificate of Title with a properly signed transfer and associated documents, a discharge of mortgage and any other encumbrance from title.
 - 3-C. I/We have directed how to pay the purchase money, and you have paid it to me/us as directed.
4. Outstanding rates and land tax will be adjusted on settlement and I/we will pay my/our share up to the date of settlement.
5. I/We will pay Land & Property Information Office registration fees on the discharge of any mortgage or removal of any other encumbrance from title. Fees will be adjusted on settlement.
6. I/We acknowledge that it is our personal responsibility whether or not I/we choose to obtain independent professional legal or financial advice prior to deciding to proceed with the sale of our land.
7. I/We were able to have this form and the information pack documents translated into my/our own language if I/we do not read English.

I/We are the registered owner/s of the land described above, and have authority to sign this form. The information I/we gave in this form is true and correct.

I/We request that this Offer to Sell be registered by the Foundation and that the Foundation send to me/us the documents required to complete the sale once you have decided to proceed.
